Required ELD In-Cab Materials

ELD Mandate: Required In-vehicle Information

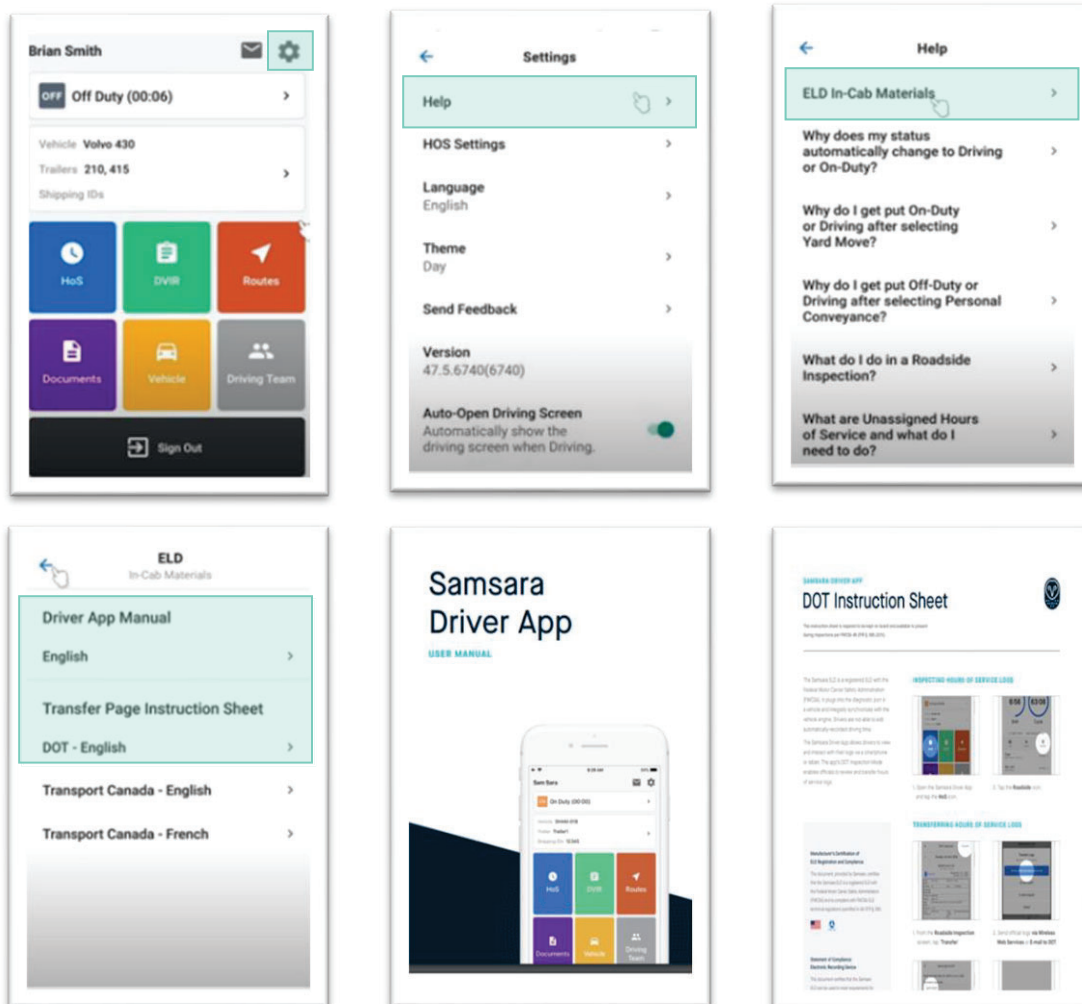
In 49 CFR 395.22, the ELD mandate requires that every ELD-equipped vehicle must have documents describing how a driver can operate the device, including:

- **Eight (8) days of blank paper logs** in the event of an ELD malfunction
- **User Manual** for the ELD
- **Driver Instruction Sheet** describing:
 - How to operate the ELD in the event of an inspection; and
 - ELD "malfunction reporting requirements" and "record keeping procedures during ELD malfunctions"

Samsara has the **User Manual** and **Driver Instruction Sheet** available in the Samsara Driver App. **Eight (8) days of blank logs** will be provided by Panther.

Accessing ELD In-Cab Materials from the Driver App:

Start by logging into the Driver App. From there, select **Settings** > **Help** > **ELD In-Cab Materials** > **Driver App Manual** or **Transfer Page Instruction Sheet** to view.



In Summary

The ELD mandate requires that a user manual and driver instruction sheet are available in the vehicle's cab.

- **The driver instruction sheet is required to be within reach of the driver and is located in the front of your permit binder. Make sure you locate and understand the instructions.**
- The FMCSA has also clarified that the manuals may be made available to drivers in the vehicle in electronic form. Having these documents available in the driver app are fully compliant with FMCSA.



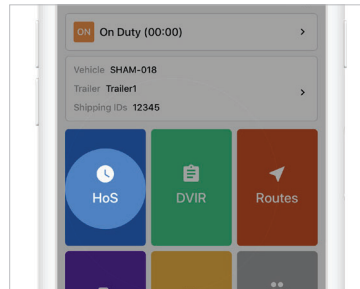
DOT Instruction Sheet

This instruction sheet is required to be kept on board and available to present during inspections per FMCSA 49 CFR § 395.22(h).

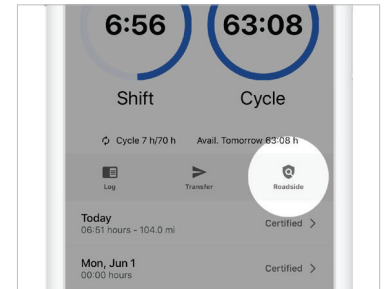
The Samsara ELD is a registered ELD with the Federal Motor Carrier Safety Administration (FMCSA). It plugs into the diagnostic port in a vehicle and integrally synchronizes with the vehicle engine. Drivers are not able to edit automatically-recorded driving time.

The Samsara Driver App allows drivers to view and interact with their logs via a smartphone or tablet. The app's DOT Inspection Mode enables officials to review and transfer hours of service logs.

INSPECTING HOURS OF SERVICE LOGS

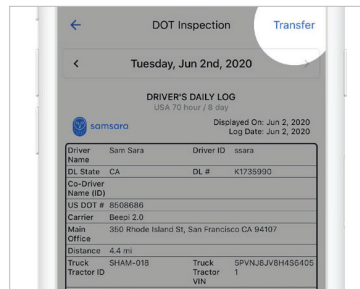


1. Open the Samsara Driver App and tap the **HoS** icon.

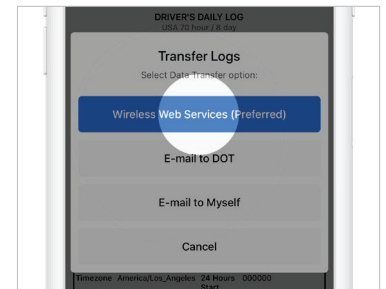


2. Tap the **Roadside** icon.

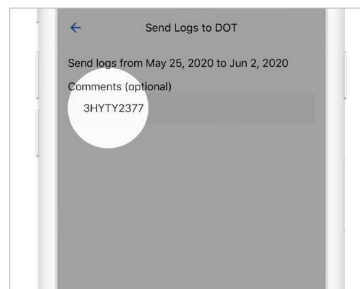
TRANSFERRING HOURS OF SERVICE LOGS



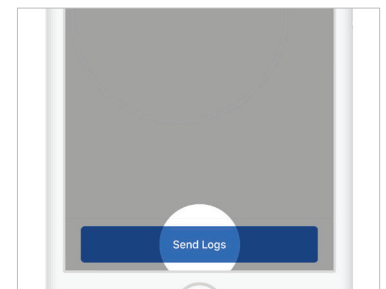
1. From the **Roadside Inspection** screen, tap '**Transfer**'.

Section 1: Federal Motor Carrier Safety Regulations

The Federal Motor Carrier Safety Regulations (FMCSRs) set forth minimum standards for those involved with the operation of commercial motor vehicles in interstate commerce. The Department of Transportation (DOT) requires drivers to be knowledgeable of and comply with FMCSRs that apply to them. An explanation and interpretation of these regulations can be found in the Federal Motor Carrier Safety Regulations Pocketbook.

Driver's License or Commercial Driver License (CDL)

Maintain a valid state issued unrestricted license with appropriate class and endorsements.

Physical Qualifications and Examinations

Medical Examiner's Report (MER)

Maintain a passing Department of Transportation physical examination completed by a company approved Certified Medical Examiner, other than a chiropractor, listed on the National Registry of Certified Medical Examiners (National Registry).

Medical Examiner's Certificate (MEC)

CDL holders must provide their SDLA with a copy of their ME Certificate. This information is only being added to the State driving records of CDL holders. Non-CDL holders are not required to self-certify or submit a copy of their ME Certificate to their SDLA. CDL holders, who are found driving in a category other than one to which they self-certified, are subject to suspension or revocation of their commercial driving privileges. CDL drivers, who do not update the expiration date of their ME Certificate with their State, will have their commercial driving privileges downgraded, and will not be eligible to drive a commercial motor vehicle that requires a CDL. Section 2: Emergency Notification and Incident Reporting

The following events must be reported immediately no matter the severity or fault.

Emergency Notification

- Accident or Incident
- Chemical Release (Hazardous Materials, Fuel, etc.)
- Theft (Equipment or Cargo)

Incident Reporting

- Roadside Inspection
- Citation
- Damage (Equipment or Property)
- Injury

Notification and Reporting

In the event of an emergency or incident, follow the procedures as outlined below:

Step 1: Notify local or state authorities immediately.

Step 2: Contact Safety Compliance to report the emergency or incident.

Step 3: Maintain an open line of communication and assist Safety Compliance and/or company representative in gathering all necessary information.

Section 3: Hours of Service of Drivers

Required ELD In-Cab Materials

In 49 CFR 395.22, the ELD mandate requires that every ELD-equipped vehicle must have documents describing how a driver can operate the device, including:

- Eight (8) days of blank paper logs in the event of an ELD malfunction
- User Manual
- Driver Instruction Sheet describing:
 - How to operate the ELD in the event of an inspection; and
 - ELD "malfunction reporting requirements" and "record keeping procedures during ELD malfunctions" DOT Inspection Instructions.

The ELD mandate requires that a user manual and driver instruction sheet are available in the vehicle's cab.

- *The driver instruction sheet is required to be within reach of the driver and is located in the front of your permit binder. Make sure you locate and understand the instructions.*
- The FMCSA has also clarified that the manuals may be made available to drivers in the vehicle in electronic form. Having these documents available in the Samsara driver app are fully compliant with FMCSA.

Hours of Service

Commercial Motor Vehicle (CMV)

- 70-Hour Rule – total time spent Driving and On-Duty cannot exceed 70 hours in any 8-day period.

Non-Commercial Motor Vehicle (NCMV)

- 16/5-Hour Rule – total time spent On-Duty cannot exceed 16 hours and must be followed by a 5 consecutive hour rest break. On-Duty time starts when vehicle is moved/driven for any reason.

Driver Vehicle Inspection Report (DVIR)

- Pre/Post-trip Inspections – federal regulations requires every driver to prepare a DVIR at the completion of each day's work on each vehicle operated.

Personal Conveyance

- Use of personal conveyance is permitted under certain circumstances with prior review and approval from Safety Compliance.

Driver Responsibilities

Driver responsibilities outlined in [49 CFR 395.24](#) include:

- (a) **In general.** A driver must provide the information the ELD requires as prompted by the ELD and required by the motor carrier.
- (b) **Driver's duty status.** A driver must input the driver's duty status by selecting among the following categories available on the ELD:
 - (1) "Off duty" or "OFF" or "1";
 - (2) "Sleeper berth" or "SB" or "2", to be used only if sleeper berth is used;
 - (3) "Driving" or "D" or "3"; or

(4) “On-duty not driving” or “ON” or “4”.

(c) **Miscellaneous data.**

(1) A driver must manually input the following information in the ELD:

- (i) Annotations, when applicable;
- (ii) Driver's location description, when prompted by the ELD; and
- (iii) Output file comment, when directed by an authorized safety officer.

(2) A driver must manually input or verify the following information on the ELD:

- (i) Commercial motor vehicle power unit number;
- (ii) Trailer number(s), if applicable; and
- (iii) Shipping document number, if applicable.

(d) **Driver use of ELD.** On request by an authorized safety official, a driver must produce and transfer from an ELD the driver's hours-of-service records in accordance with the instruction sheet provided by the motor carrier.

Section 4: Hazardous Materials

Hazardous Shipments

Check the bill of lading or other shipping papers to determine if a shipment contains hazardous materials. Hazardous shipments will be indicated in one or more of the following ways:

- Hazardous materials will be listed first, before nonhazardous materials.
- An “X” will appear in a hazardous materials column.
- Hazardous materials will be entered or highlighted in a different color than nonhazardous items.

Hazardous Materials Shipping Papers

Make sure shipping papers contain the following required information:

- Proper shipping description (**ISHP**)
 - **(I)** Identification Number
 - **(S)** Proper Shipping Name
 - **(H)** Hazard Class
 - **(P)** Packaging Group
- Handling Units, Type of Packages, Total Quantity, and Weight for each HM listed
- Emergency Response Telephone Number
- Shipper’s Certification and Signature

Check for the following:

- Proper labeling and marking.
- Signs of damage, leakage, or any other condition that indicates that the shipment cannot be transported safely.
- Secure hazardous materials in the trailer so that the containers will not be damaged during transit.
- Make sure unit is properly placarded (front, sides, rear), placards are applied correctly, secure, and maintained during transportation.

Note - Contact the Hazardous Materials Helpline at 888-232-4096 before leaving the shipper’s location.

On The Road

Keep shipping papers for hazardous materials shipments visible and within reach while restrained by seat belt.

- Place hazardous materials shipping papers on top of other shipping papers.
- Place hazardous materials shipping papers on your seat if you leave the cab.
- Follow all applicable hazardous materials routing (i.e. highways, tunnels, bridges, etc.), attending vehicle, fueling, and parking requirements.
- Stop placarded units before reaching nearest rail of crossing to make sure the tracks are clear.
- Do not smoke or carry any lighted smoking materials on or within 25 feet of a vehicle containing explosives, oxidizer, or flammable materials.
- Contact the Hazardous Materials Helpline:
 - If you discover your vehicle and/or trailer has a flat, leaking, or improperly inflated tire
 - To report any incident involving hazardous materials during transportation (i.e. placards, crash, fire, unintentional release, damaged packages, etc.)

Section 5: Maintenance and Inspection

Maintenance and Inspection Policy

Power Units

Panther Premium Logistics and the Department of Transportation require all owners and drivers to keep proper, up to date, maintenance and inspections of all vehicles leased to Panther. The vehicle owner has the responsibility to make sure all maintenance and inspections are completed in a timely manner and Panther has the responsibility to enforce this policy.

Each unit with a GVW 10,001 and above will have a DOT annual inspection completed no less than every 12 months. A copy must be kept with the vehicle, and one sent to the Vehicle Compliance Specialist to be retained in the vehicle maintenance file. All vehicles with a GVW of 10,000 and below must have a Panther vehicle inspection completed no less than every 12 months. The “Contractor” will make the vehicle available to be inspected prior to the expiration date. A record of the inspection will be retained in the vehicle maintenance file.

All vehicle maintenance must be recorded, and Vehicle Maintenance Records submitted every ninety (90) days using the Quarterly Maintenance Report located in the Safety Compliance section of the [Panther Fleet](#) website.

The Vehicle Maintenance Record must be always kept current. The owner’s failure to keep the vehicle maintenance file in accordance with DOT regulations will result in the vehicle being placed out of service.

Trailers

All trailers are on a scheduled 6-month or 9-month maintenance program. The driver will be contacted as to when the trailer is due and where to take it to have the maintenance done. Panther covers all costs for maintenance and inspections.

All trailers are required to be washed at a Blue Beacon wash facility. You may have it done twice a month at no cost to the contractor. Make sure they know you are with Panther Premium Logistics. This account will only cover the trailer wash and not the tractor.

Vehicle Inspections and Reports

A pre-trip inspection shall be completed prior to operating a motor vehicle and post-trip inspection at the completion of each day’s work on each vehicle operated.

A Driver Vehicle Inspection Report (DVIR) must be prepared and signed by the driver of a CMV for each vehicle operated (straight truck, tractor, and trailer) when defects or deficiencies are discovered by or reported to the driver, this includes defects or deficiencies discovered during pre/post-trip and roadside inspections.

Maintenance and Inspection Paperwork

You must submit the following paperwork to expeditefleetmaintenance@arcb.com by due date noted.

Document Type	Due Date
Driver's Vehicle Inspection Report (DVIR)	Must be prepared and signed by the driver of a CMV for each vehicle operated (straight truck, tractor and trailer) when defects or deficiencies are discovered by or reported to the driver, this includes defects or deficiencies discovered during pre/post-trip and roadside inspections.
Roadside Inspections (RSI)	Report immediately and copy forwarded within 24 hours.
Violations, Citations, Warnings, etc.	Report immediately and copy forwarded within 24 hours.
Vehicle Registration	Submit vehicle registration prior to expiration date.
Vehicle Maintenance Records	Submit Vehicle Maintenance Records every ninety (90) days using the Quarterly Maintenance Report located in the Safety Compliance section of the Panther Fleet website.
Annual DOT Inspection	Submit annual DOT Inspection with Inspector Qualifications prior to expiration date.

Section 6: Controlled Substances and Alcohol Use and Testing

The purpose of the FMCSA issued regulations is to establish programs designed to help prevent accidents and injuries resulting from the misuse of alcohol or use of controlled substances by drivers of commercial motor vehicles.

The company will comply with these regulations and is committed to maintaining a drug-free workplace.

The use, sale, purchase, transfer, possession, or presence in one's system of alcohol or controlled substances (except medically prescribed drugs) by any driver while on the company premises, engaged in company business, operating company equipment, or while under the authority of the company is strictly prohibited.

As an independent contractor, you are required to be in compliance with these regulations whenever performing any safety-sensitive function to include the following: driving, time spent waiting to be dispatched, on the shipper, company, or consignee property, maintaining or inspecting equipment, being in or on a Commercial Motor Vehicle (CMV), loading or unloading, supervising the loading or unloading, attending a vehicle being loaded or unloaded, repairing, obtaining assistance or attending a disabled vehicle, actually performing, ready to perform, or immediately available to perform the mentioned safety-sensitive duties on behalf of the company.

As required by [49 CFR Part 382](#), the company will perform the following:

- Pre-Employment Testing ([49 CFR 382.301](#) and [382.701](#))
- Pre-Employment Drug & Alcohol Clearinghouse Query ([49 CFR 382.701](#))
- Post-accident Testing ([49 CFR 382.303](#))

According to FMCSA regulations, the driver must be tested for drugs and alcohol as soon as possible after the accident if the accident involved:

- Fatality
- Bodily injury with immediate medical treatment away from the scene and the driver received a citation.
- Disabling damage to any motor vehicle requiring tow away and the driver received a citation.
- Random Testing ([49 CFR 382.305](#))
- Reasonable Suspicion Testing ([49 CFR 382.307](#))
- Annual Drug & Alcohol Clearinghouse Query ([49 CFR 382.701](#))

Section 7: Cargo Securement

Cargo Securement Rules

The guiding principle of cargo securement is that cargo being transported on public roads must remain secured on or within the transporting vehicle. Proper cargo securement prevents cargo from shifting or leaking, spilling, blowing, or falling from the vehicle.

Protection Against Shifting and Falling Cargo

As a driver, it is your responsibility to make sure that the vehicle's cargo and equipment are properly distributed and secured before you operate a commercial motor vehicle.

- In the U.S., you must follow rules in [49 CFR Part 393, Subpart I](#), Protection Against Shifting and Falling Cargo.
- In Canada, you must comply with National Safety Code Standard 10, Cargo Securement, and provincial standards.

All cargo must be contained, immobilized, or secured so that it does not:

- Leak,
- Spill,
- Blow off the vehicle,
- Fall from the vehicle,
- Fall through the vehicle,
- Otherwise become dislodged from the vehicle, or
- Shift upon or within the vehicle to such an extent that the vehicle's stability or maneuverability is adversely affected.

Section 8: Handling Shipment Exceptions

- **Pick-up Exceptions**
 - **Shipper Load and Count (SLC)**
 - If unable to inspect or verify number of handling units and/or cargo securement.
 - Notate bill of lading with “SLC” as handling units and seal number applied by shipper.
 - **Shortage**
 - Review shortage with shipper and request a corrected bill of lading.
 - If corrected bill of lading is not provided, notate bill of lading with actual number of handling units received.
 - Contact Safety Compliance to report shortage.
 - **Damage**
 - Review damaged handling units and commodity with shipper.
 - Take picture of damaged handling units and forward to Safety Compliance.
 - Contact Safety Compliance to report damage prior to loading.
 - If damage is approved, notate bill of lading with number of handling units and commodity damaged.
 - **Hazardous Materials**
 - Do not accept handling units that are leaking and or damaged.
 - Make sure Hazardous Materials shipping papers contain the following required information:
 - Proper shipping description (**ISHP**)
 - **(I)** Identification Number
 - **(S)** Proper Shipping Name
 - **(H)** Hazard Class
 - **(P)** Packaging Group
 - Handling Units, Total Quantity, and Weight for each HM listed
 - Emergency Response Telephone Number
 - Shipper's Certification and Signature
- Note - Contact the Hazardous Materials Helpline at 888-232-4096 before leaving the shipper's location.***
- **Delivery Exceptions**
 - **Shipper Load and Count (SLC)**
 - Verify seal is intact and number entered on bill of lading with consignee.
 - **Shortage**
 - Review shortage with consignee.
 - Notate bill of lading/delivery receipt with actual number of handling units delivered.
 - Contact Safety Compliance to report shortage.
 - **Damage**
 - Review damaged handling units and commodity with consignee.
 - Notate bill of lading/delivery receipt with number of handling units and commodity delivered damaged.
 - Take picture of damaged handling units and forward to Safety Compliance.
 - Contact Safety Compliance to report damage prior to unloading.
 - **Refusal**
 - Contact Safety Compliance to report refusal.

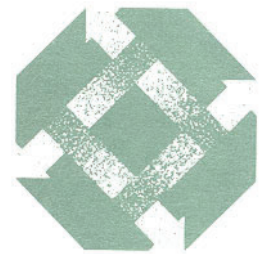

The Authority shall be included as an Additional Insured, using ISO Additional Insured Endorsement CG 20 10 11 85 or its equivalent, under the CGL policy and Business Auto policy, as required.

Business Auto Liability Insurance - The Applicant shall maintain Business Automobile Liability coverage, with no less than a \$5,000,000 Combined Single Limit, which shall cover liability arising out of the Applicant's use of any motor vehicle, whether owned, leased, hired, or non-owned.

The Applicant shall provide a current copy of the Endorsement for Motor Carrier Policies of Insurance for Public Liability (MCS-90) form.


In addition to the \$100.00 application fee, the permittee must purchase a single use TRIP PERMIT. All Explosive Trip permits must be ordered through the Highway Oversize/Overweight Credentialing System (HOOCs) (<https://hoocs.dot.ny.gov/HOOCs/>). Commercial users must have an One Stop Credentialing and Registration (OSCAR) account to apply for a Special Hauling Permit through HOOCs.

The application and individual trip fees are in addition to the regular tolls.

The vehicle operator must carry the approved 12-MONTH PERMIT and one copy of the TRIP PERMIT in the vehicle at all times.

4. **Permit Restrictions**

- a. This 12-MONTH PERMIT, though issued, or any individual trip permitted thereunder, may be cancelled or suspended without refund, at any time by the Authority's Director of Maintenance and Operations or designee, if it is deemed that travel by a vehicle carrying explosives would create a hazard because of road, weather, traffic, or any other conditions, as determined in the sole discretion of the Authority.
- b. **NO EXPLOSIVES, AS DEFINED HEREIN, MAY BE TRANSPORTED AT ANY TIME OVER THE GOVERNOR MARIO M. CUOMO BRIDGE OR THE CASTLETON-ON-HUDSON BRIDGE.**
- c. This 12-MONTH PERMIT may be revoked without refund for violation of any NYS Thruway Permit condition, requirement or for breach of any Federal, State or local law, rule, or regulation, including any and all specific DOD requirements for those carriers claiming DOD carrier certification/status.
- d. The DOD endorsement will expire on the same date as the 12-MONTH PERMIT; the Authority reserves the right to routinely audit and verify all DOD carrier permit or trip information directly with the DOD, including dates of DOD travel, trip entrance/exit information, DOD permit billings, and payment information.




